### Policy Document on Grievance Redressal Cell


The Grievance Redressal Cell of Maniben M. P. Shah Mahila Arts College, Kadi, Gujarat aims to look into the complaints lodged by any student and redress it as per requirement. The students can state their grievance regarding any academic and non-academic matter within the campus through the online and grievance/ suggestion box. The institution aims at solving the grievances of the students within stipulated academic and non-academic matter within the campus through the online and grievance/ suggestion box. The institution aims at solving the grievances of the students within stipulated time.

#### Objectives:

The Grievance Redressal Cell has been developed to settle the grievances of the students and other stakeholders within a reasonable time period for further strengthening the bond of the students with the institution by providing them with all kind of facilities to a satisfaction level for maintaining a convenient ambience of academic teaching and learning. According to the UGC (Grievance Redressal) Regulations, 2018, composition of the Grievance Redressal Committee has been constituted each year.

#### Mechanism:

- Grievance Redressal Committee shall consider only individual grievances of specific nature of students and staff.
- The Committee shall not consider any grievance of general applicability or of collective nature of raised collectively by more than one employee/student.
- Post receipt of the complaint/application the committee will decide on the merit of case regarding scope of further discussion investigation and act promptly.
- The Committee may mediate between complainant and defendant against who the complaint has been made, if required.
- Committee shall consider redressing of grievances within a reasonable time.
- The Committee will give report to the authority about the cases attended to and seek guidance from the higher authorities if required.


## Scope:

- Certain misgivings about conditions of sanitation, preparation of food, availability of transport, victimization by teachers and any other offensive activity.

- The Grievance Cell will act upon those cases which have been forwarded along with the necessary documents.







During the discussion, it emerged that there is a need to increase the awareness among students about the provisions made by universities for the implementation of UGC Student Grievances Regulations, 2023. Additionally, it was suggested that there should be periodic meetings of the Vice-Chancellor and the Ombudsperson(s) to review the implementation of the Regulations, 2023.

In view of the above, you are requested to take necessary steps to make the students aware about the implementation of the UGC Student Grievances Regulations, 2023 in your university. This can include:

- i) placing banners/boards in prominent locations throughout the campus, as well as on the campuses of affiliated colleges;
- ii) publishing information on the websites/Bulletin of Information;
- iii) any other measures that you deem appropriate.

You are also requested to organize at least one meeting of the Ombudsperson(s) every six months at the beginning of the semester with the students.

Your continued cooperation is requested as it is vital to ensure the successful implementation of the UGC Regulations (Redressal of Grievances of Students) in 2023 to create a fair and responsive academic environment.
