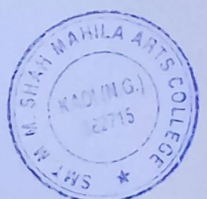

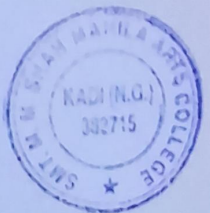

No player, who choose to play on behalf of the State team, in any tournament, without prior permission of the concerned university and in case of tournaments in which Indian Universities teams are also participating, without prior permission of the Association of Indian Universities, also be allowed to participate in any university, inter-collegiate and inter-University tournaments. It was for the concerned university to take appropriate disciplinary action against players playing on behalf of State teams without their permission as reflected in the preceding sentence.

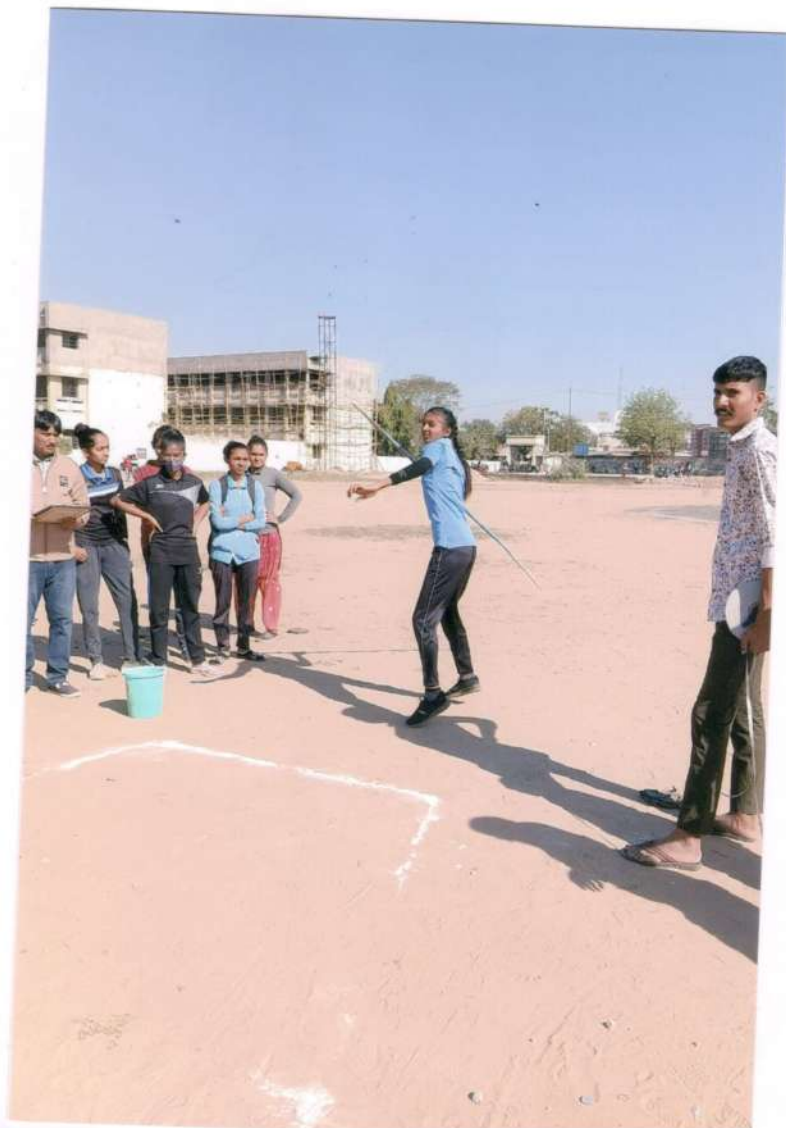
