REPORT ON ZERO TOLERANCE POLICY AWARENESS PROGRAM

On July 10, 2019, Smt. M. M. Shah Mahila Arts College, Kadi, hosted a Zero Tolerance Policy Awareness Program on "Empower & Educate: Fighting Sexual Harassment" to promote a safe and inclusive campus environment. Held in the college classroom, the event attracted over 58 participants, including students, faculty, and staff. Facilitated by Principal Dr. Hina Patel, Legal Consultant Smt. Ashlesha Brahmbhatt and Ms. Sonara from Kadi Police Station, the session detailed the college's Zero Tolerance Policy, as outlined in the 2019-20 policy document, addressing prohibited behaviours such as harassment (e.g., sexual assault, threatening remarks), bullying (e.g., physical threats, malicious rumours), discrimination (e.g., racial slurs, gender-based exclusion), and micro-aggressions (e.g., racially insensitive comments, scheduling conflicts with religious holidays). Through engaging presentations and interactive discussions, attendees gained clarity on reporting procedures and disciplinary actions, ranging from warnings to termination or rustication. Feedback indicated that 90% of participants felt more confident in identifying and addressing misconduct. The college committed to conducting annual programs to sustain awareness.
