REPORT ON ZERO TOLERANCE POLICY AWARENESS PROGRAM

On July 14, 2020, Smt. M. M. Shah Mahila Arts College, Kadi, conducted a Zero Tolerance Policy Awareness Program on **“Voices for Change: Building a Harassment-Free Campus”** to educate staff and students about maintaining a safe and inclusive campus environment. Held in the college classroom, the event attracted over 48 participants, including faculty, staff, and students. Led by Principal Dr. Hina Patel, Legal Consultant Smt. Ashlesha Brahmbhatt and Ms. Sonara from Kadi Police Station, the program outlined the college’s Zero Tolerance Policy, detailing prohibited behaviours such as harassment, bullying, discrimination and micro-aggressions, with examples like threatening remarks, racial slurs and insensitive comments. Through presentations, case studies, and a Q&A session, participants gained clarity on reporting mechanisms and disciplinary actions, which range from warnings to termination or rustication. Feedback revealed that 92% of attendees felt more confident in identifying and addressing misconduct. The program reinforced the college’s commitment to a respectful environment and plans are underway for annual sessions to sustain awareness.
