REPORT ON ZERO TOLERANCE POLICY AWARENESS PROGRAM

On June 25, 2021, Smt. M. M. Shah Mahila Arts College in Kadi hosted a Zero Tolerance Policy Awareness Program on "Safe Spaces, Strong Voices: Eradicating Sexual Harassment" to promote a safe and inclusive campus environment for its staff and students. Conducted in the college classroom, the event drew over 68 attendees, including faculty, administrative staff, and students. The session, facilitated by Principal Dr. Hina Patel, Legal Consultant Smt. Ashlesha J. Brahmbhatt, and Ms. S. Sonara from Kadi Police Station, provided a comprehensive overview of the college's Zero Tolerance Policy, highlighting prohibited behaviours such as harassment (e.g., sexual assault, threatening remarks), bullying (e.g., physical threats, rumours), discrimination (e.g., exclusion based on identity), and microaggressions (e.g., racially insensitive comments). Interactive discussions, case studies, and a Q&A session clarified reporting procedures and outlined disciplinary measures, ranging from warnings to potential termination or rustication. Feedback indicated that 92% of participants felt better equipped to recognize and address inappropriate conduct. The college reaffirmed its dedication to fostering a respectful environment and plans to hold annual programs to maintain policy awareness.
