➤ **Background**

This Memorandum of Understanding (MoU) is entered into between Maniben M.P.Shah Mahila Arts College, Kadi, herein referred to as "the Arts College", and Daulatbhai Trivedi Law College, Ahmedabad, herein referred to as "the Law College", with the intention of fostering collaboration and cooperation between the two institutions in the field of education and research.

➤ **Purpose**

The purpose of this MoU is to establish a framework for cooperation between the Arts College and the Law College in areas of mutual interest, including but not limited to:

1. Promoting interdisciplinary studies and research.
2. Facilitating exchange programs for students and faculty members.
3. Organizing joint workshops, seminars, and conferences.
4. Collaborating on research projects and publications.
5. Sharing resources and expertise to enhance the quality of education and research.

➤ **Terms of Agreement**

1. **Exchange Programs:** The Arts College and the Law College agree to facilitate exchange programs for students and faculty members, including but not limited to exchange of academic materials, guest lectures, and study visits.

2. **Joint Workshops and Seminars:** Both institutions may collaborate on organizing workshops, seminars, and conferences on topics of mutual interest, with the aim of fostering intellectual exchange and promoting interdisciplinary dialogue.

3. **Research Collaboration:** The Arts College and the Law College may undertake joint research projects, publish collaborative papers, and share research findings to contribute to academic scholarship and knowledge dissemination.

4. **Resource Sharing:** Both parties may share resources such as libraries, laboratories, and other facilities to support academic and research activities.

5. **Duration:** This MoU shall come into effect on the date of signing and shall remain in force for a period of three years, unless terminated earlier by mutual consent or due to unforeseen circumstances.

6. **Amendment:** Any amendment to this MoU shall be made in writing and signed by authorized representatives of both parties.

7. **Termination:** Either party may terminate this MoU by providing [insert notice period] written notice to the other party. Upon termination, both parties shall cooperate to conclude any ongoing activities in an orderly manner.

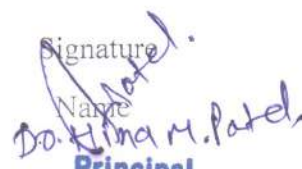

- **Recognition & Certification:** Successful completion of the program added **value to students' academic and professional profiles.**

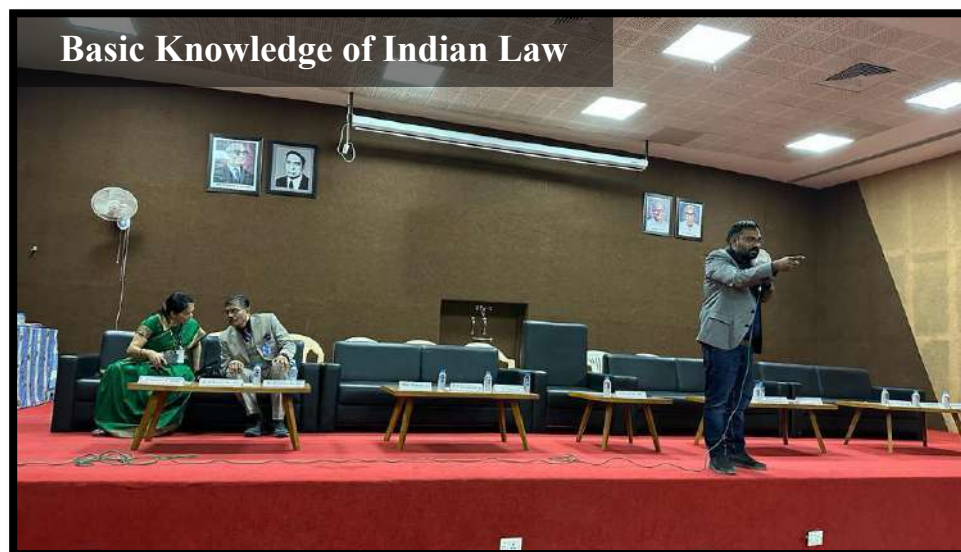
Conclusion
